Each manufacturer, producer, importer, downstream user or recipient respectively of the substances, preparations and articles are to, on demand of the enforcing authorities, to facilitate the operations these accomplish in virtue of the national REACH law of 27 April 2009. In the event of conviction incurred to the above mentioned measures shall be paid by the offender. In all other cases, these costs shall be paid by the State. Penal sanctions Whoever commits a violation to the articles 5to 9, 9to 12, 14, 17 to 19, 21, 22, 25, 27 to 41, 46, 56, 60 to 62, 65 to 68, 74 and 129 of the REACH regulation, is punished with a one to three year prison sentence and a fine from 251 to 50.000 euros, or one of these sanctions only. The same penalty is applied in case of obstruction of the above mentioned administrative measures.
