

Until 2007, Europe lacked a vital tool to defend nature and combat climate change. Using law to protect the environment was a common concept in the United States but had not taken root over the Atlantic. ClientEarth changed that.

Our client is the Earth

We are an environmental charity with a unique approach. We shape and enforce the law to empower people and defend the planet, focusing our legal efforts on carefully identified global challenges.

Case by case, we are changing the face of global environmental action. Our model is innovative, bold and a game-changer in the fight to secure a healthy planet.

Shaping the law

We make sure environmental law starts with science and reflects economic, political and cultural realities. Our international reputation as legal and policy experts gives us a strong basis to intervene where it is needed.

Our finance lawyers issue analysis that sculpts UK corporate and pensions law, setting the direction for how companies and investors play their part in preventing climate change.

We have secured a stronger future for Europe's fish stocks, making sure sustainability is at the heart of the EU policy that dictates how much fishers can catch.

Across Africa, our teams work with communities and local lawyers to develop and enforce national forest laws.

Recognising our unique expertise in environmental law and policy, the Chinese government has sought our assistance in shaping an enhanced environmental legal system.

Enforcing the law

A law is just words on a page unless it is enforced – and increasingly, we are taking up this challenge. Consistently scoring victories in the EU, we are expanding our influence ever further afield.

We have won successive cases on access to justice in the EU, protecting and preserving the right of people and NGOs to go to court to fight for their environment.

In UK, German, Czech, Polish, Italian, Belgian, French and Slovakian courts, we have defended the right to clean air, forcing governments to develop credible solutions to stop illegal air pollution.

We have thwarted plans by the Polish government to build enormous new coal plants and fell acres of ancient forest.

Through innovative legal interventions, we have forced polluting companies to come clean on the risks of their products and practices, shifting international markets towards cleaner growth.

climate change and pollution

Cleaning up our air

We have made air pollution a front-page issue all over the EU. Our lawyers have scored three resounding victories in the UK courts, defending people's right to breathe clean air. Now, we are fighting the battle in cities across Europe, systematically challenging national governments over illegal air quality in the courts.

Our approach is holistic. We are also finding legal routes to tackle emissions cheating, making sure vehicle approval procedures filter out illegally polluting cars, and addressing the tax incentives that keep dirty transport on the roads.

Designing a clean energy future

We need to produce clean, low-carbon energy but ongoing use of fossil fuels is damaging the climate, nature and people's health. Our coal team is working with partners all over Europe, successfully blocking polluting plants and challenging the public finance that keeps coal alive. Together we are accelerating the end of the coal era.

Combating

Moving to a clean energy economy means empowering people and communities. Our energy specialists are working to get the right EU policies to support and scale renewables, storage and community-produced energy. Bringing the Paris Agreement to life

As leaders in the burgeoning area of climate law, we are pushing governments worldwide to establish national and regional climate laws, plans and policies to uphold the Paris Agreement and speed the energy transition.

Alongside our work with governments, our climate finance team is compelling investors and business leaders to put environmental risk and opportunity at the core of corporate decisions and investments, using existing law to drive this shift.

Our 2018 UK air pollution victory made legal history. Ruling on the case, High Court judge Mr Justice Garnham gave exceptional praise, calling ClientEarth "an expert claimant" and a "valuable monitor" of the UK government's actions

Legal landmark

Our clean air cases in Germany went all the way to the country's top court. The judges ruled that German cities must introduce diesel bans when it is the most effective way to protect people's health.

Hot on the heels of the diesel emissions scandal, faith in manufacturers was already low and the ruling sent diesel sales plummeting. Our action is accelerating the transition to low emission vehicles, protecting people's health and making cities a better place to live.

In the next five years

We will use the law to:

- Push governments and companies to slash carbon emissions by 2050
- Compel authorities to cut illegal air pollution across Europe
- Take Europe beyond coal power and into a cleaner energy era by 2030
- Fight toxic pollution by making sure that the products we use, and the way we make them, are safe

Tackling harmful chemicals

From children's toys to plastics and make-up, products we use every day often contain chemicals known or suspected to be dangerous. The EU has world-leading chemicals laws but it has not been effective at putting them into practice – and many issues are still not addressed by existing laws.

Our lawyers are working to expand and reinforce EU chemicals law to safeguard people's health. We are helping to score victories that limit the influence of those with strong vested interests in downplaying the impact of harmful chemicals on our health and the environment.

Everyone relies on our magnificent natural world. We are using the law to stop damage to our oceans, forests and wildlife, so that nature can flourish.

habitats, wildlife and resources

Inspiring a sea change for our oceans

As our oceans come under ever greater stress, we are shaping and enforcing laws that protect marine habitats, wildlife and fish stocks. We are finding legal routes to combat marine pollution and putting sustainability at the centre of EU fisheries management. Beyond Brexit, we are working to ensure that the UK commits to sustainable standards for commercial fishing.

We work on the consumer side too. We pioneered the Sustainable Seafood Coalition (SSC), which unites the majority of UK retailers in voluntary sourcing and labelling codes for the seafood they sell. These far exceed sustainability standards under UK environmental law.

Securing a future for forests

Protecting

The world's forests are one of our biggest natural defences against climate change. They are home to diverse ecosystems and provide livelihoods for communities across the planet. But every day, swathes of forest are logged for timber, chipped and burned for energy, or cleared for agricultural commodities and industrial development.

In Central and Western Africa, we work with local lawyers and communities to design, strengthen and enforce laws around the use of forests and land. We also aim to cut illegal logging by blocking illegal timber from the marketplace, and reduce deforestation by changing how companies and investors perceive forest risk commodities, like soya, palm and biomass.

Revitalising global wildlife

Global wildlife populations are in trouble. Countless species – from large mammals to bees, butterflies and birds – are in rapid decline, with consequences for food security, livelihoods and the survival of key ecosystems.

We are working to protect and rehabilitate natural habitats and restore keystone species by strengthening laws and making sure they are properly enforced. We focus on protecting key European nature sites and combating the misuse of pesticides.

- Help implement sustainable EU fishing quotas by 2020
- Protect wildlife and ecosystems
- Preserve global forests by focusing on the international timber trade

Legal landmark

We stepped in to save Poland's ancient Białowieża Forest from illegal logging, to safeguard this home of rare and endangered species.

Our action, working with national partners, prompted an historic ruling from the European Court of Justice, which told the Polish government its plans to log were illegal and threatened hefty daily fines until it stopped – a victory for wildlife and ecosystems.



People have the right to a say in the rules that protect the environment but their way is often blocked. We work to enforce international laws to make sure people have a clear path to the courts.

Upholding access to justice

When we started our work, barriers to justice were preventing individuals and organisations from bringing their environmental cases to the courts.

The earliest cases at ClientEarth, taken against the UK, Germany, and the EU itself, set out to challenge prohibitively expensive court costs and standing rules which were undermining access to justice.

Our success in these cases provided the foundations for all of ClientEarth's work and we continue to fight for people's right to go to court for the environment.

A new environmental era for China

Defending

Recent reforms in China have opened the doors to environmental lawsuits brought by ordinary people, and the judicial arm of the government, against polluting companies. This has substantially increased the number of people working in the field – and the number of challenges against polluters. People are now seeing environmental law differently.

Our office in Beijing is making a leading contribution to the development of environmental rule of law in China. With our formal status as an NGO, we are helping to modernise environmental governance and empowering other organisations to further this work.

Legal landmark

ClientEarth is leading unique work in cooperation with the Supreme People's Court in China, training hundreds of judges to deal with environmental cases, and prosecutors to lead them. We are also building a fund to finance technical experts for these cases, helping to ensure that good precedents are set.

As China's economy grows, our work is putting environmental justice high up the legal agenda, and ensuring national courts are ready to engage with environmental law.

Securing community forest rights

The law is only as good as people's ability to enforce it. Our long-term work in Gabon, Ghana, Ivory Coast, Liberia and Congo ensures people can make legal interventions to defend their environment.

In Ghana, we have worked with local communities to compile the full body of national forest law into a "Forest bible" which residents can now use to negotiate with government authorities. We ensure that rights of local communities are recognised so they can take a leading role in protecting the forests.

In the next five years

We will use the law to:

- Help establish a sound environmental rights system in China
- Take our access to justice cases beyond Europe, opening new avenues for people to defend their environment
- Enshrine community rights in forest laws in Central and West Africa and beyond

Trade that respects the planet

International trade agreements are a global battleground for environmental rights, too often favouring the interests of business and investors, rather than people and planet.

Investors should not be able to hold governments to ransom over laws designed to protect nature, and trade agreements must not have a chilling effect on environmental safeguards.

We are pushing for scrutiny of investment rules in key international trade deals to make sure they comply with EU law.



Global challenges, global ambitions

The immense power of the law to protect the environment has yet to be fully harnessed on the global stage. We are sowing the seeds for it to be used the world over.

Environmental problems know no borders. Our aim is to increase our impact even further by working with partners in different countries, building legal capacity where it is needed most.

It's a new way of working. Finding the right partners means we become a force for even greater change. Together, we develop strategies to leverage the power of the law for public good.
